

## Statistical indicators

According to data from the Statistical Office of Montenegro (MONSTAT), a total of 2,587,255 tourist arrivals were recorded in 2021, while the total number of overnight stays was 9,872,573. Arrivals in 2021 rose by 276.27% compared to 2020, accounting for 63.23% of the arrivals recorded in 2019. With regard to overnight stays, in 2021 there was an increase of 281.58% compared to 2020, or 68.33% of the level recorded in 2019.

In 2021, the top ten source markets in terms of arrivals were: Serbia (27.6%), Bosnia and Herzegovina (13.8%), Ukraine (8.7%), Russia (6.9%), Kosovo (6.9%), Germany (4.5%), Albania (3.6%), Poland (2.6%), France (2.3%) and North Macedonia (1.8%).




Figure 2: Arrivals in 2021 by source market (10 most important markets) (Source: MONSTAT)

In 2021, the top ten source markets in terms of overnight stays were: Serbia (32.6%), Bosnia and Herzegovina (12.9%), Russia (12.1%), Ukraine (9.2%), Kosovo (4.8%), Germany (4%), Poland (2.3%), Albania (1.9), North Macedonia (1.7%) and France (1.6%).





Figure 3: Overnight stays in 2021 (10 most important markets) (Source: MONSTAT)

Looking at tourist traffic by month in 2021, there was a clear increase in tourist arrivals compared to the previous year, except in the first quarter, when there was a decrease due to COVID-19 measures in force at the time, which did not exist in the first quarter of 2020.

According to data from MONSTAT, in 2021 Montenegro recorded 730,423 tourist arrivals in collective accommodation facilities (hotels and similar accommodation facilities), which is an increase of 171.66% compared to 2020, representing 56.48% of the level recorded in 2019. There were 2,984,840 overnight stays in collective accommodation in 2021, which is an increase of 212.23% compared to 2020, representing 63% of the level recorded in 2019.

## Number of arrivals and overnight stays 2021/2020 in collective accommodation





Figure 4: Number of arrivals and overnight stays in collective accommodation in 2020/2021 (Source: MONSTAT)


In 2021, the most important source markets in terms of tourists who stayed in collective accommodation facilities (hotels and similar accommodation facilities) were Serbia (23.1%), Ukraine (9.1%), Bosnia and Herzegovina (7,7%), Albania (6.2%), Kosovo (6.1%), Russia (5%), Germany (4.7%), France (2.9%), Israel (2.8%) and Poland (2.8%).

In 2021, the most important source markets for overnight stays in collective accommodation (hotels and similar accommodation facilities) were Serbia (28.3%), Ukraine (12.6%), Bosnia and Herzegovina (8.8%), Russia (5.4%), Kosovo (4.7%), Germany (4.6%), France (3.5%), Poland (3.2%), Albania (3.1%) and Israel (2%).

## 1.1. Data from relevant institutions in monitoring tourist traffic

According to data from the Airports of Montenegro, 75.36% more aircraft movements were recorded and 148.41% more passengers were handled in 2021 than in 2020. Broken down by airports, 90.18% more passengers and 48.14% more flights were handled at Podgorica Airport, while 111.74% more flights and 253.68% more passengers were handled at Tivat Airport.




Figure 7: Passenger and aircraft traffic at Montenegrin airports in 2020 and 2021 (Source: Airports of Montenegro)

According to data from the Agency for Electronic Communications and Postal Services (EKIP), the total number of active roaming users in Montenegro, who used the services of Montenegrin mobile operators in 2021, amounted to 5,487,869, up by 151.55% compared to 2020 and representing 76.04% of the level recorded in 2019.


According to data from the Public Enterprise for National Parks of Montenegro, there were 396,652 visits to the national parks in 2021, which is an increase of 736.6% compared to the previous year. In 2021, ticket sales amounted to  $\in$  1,135,930, which is an increase of 732.71% compared to the previous year.

In 2021, a total of 8,490,880 passenger arrivals into Montenegro were recorded at border crossing points, which is an increase of 90.8% compared to 2020. The number of motor vehicle crossings increased by 134.8% compared to the year before, with a total of 4,284,233 motor vehicles crossing the national borders.

According to data from Monteput, 2,613,715 motor vehicles passed through Sozina Tunnel in 2021, up 34.2% compared to 2020.

**Financial indicators** 

According to data from the Central Bank of Montenegro, €757.8 million was generated from the travel & tourism sector in 2021, up by 424.42% compared to 2020 and accounting for 68.97% of the level recorded in 2019.



## Revenues from travel/tourism 2021/2020 (€ thousand)

Total assigned revenues, which include revenues from occupancy tax, tourist tax and membership contributions, amounted to €2,893,658.62 in 2021, which is an increase of 131.92% compared to assigned revenues generated in 2020. The State Treasury revenue from occupancy tax in 2021 amounted to €1,358,551.92, up 270.14% compared to 2020. In 2021, €897,042.79 was generated in revenue from tourist tax, which is an increase of 126.19% compared to 2020, while €638,063.91 was raised from membership contributions, up 31.81% on the year before.






Figure 8: Comparison of revenues from travel & tourism in 2020 and 2021 (€ thousand) (Source: Central Bank of Montenegro)
